Some of the accomplishments of the DAB include:

- Completed construction of inclusive playground at Memorial Park.
- Proper use and placement of handicapped parking signs throughout the township.
- Installation of accessible doors in the Township building and library.
- Review of construction and renovation plans for commercial properties, and ongoing communication with all commercial property owners regarding the ADA.
- Worked closely with LMT police department to update the emergency services database.
- Assisted in the development of the ADA Transition plan along with the LMT Parks and Recreation Department.

WHAT WE'VE DONE (continued)

- Volunteer at community events such as the 5K Anyway Color Fun Run for Accessibility to raise funds for future projects.
- Installation of an audible traffic signal on Big Oak Road.
- Worked with Parks and Recreation department to install accessible pool lifts.
