

ORDINANCE NO. 76

AN ORDINANCE OF THE BOARD OF SUPERVISORS OF THE TOWNSHIP OF LOWER MAKEFIELD, BUCKS COUNTY, PENNSYLVANIA, CREATING A PARK AND RECREATION BOARD, ESTABLISHING ITS MEMBERSHIP AND DELINEATING ITS POWERS AND DUTIES.

BE IT, AND ITS IS HEREBY ENACTED AND ORDAINED by the

Supervisors of the Township of Lower Makefield, Bucks County, Pennsylvania:

SECTION I. Creation of Park and Recreation Board:

A Township Park and Recreation Board is hereby created and established in the Township of Lower Makefield, County of Bucks and Commonwealth of Pennsylvania.

SECTION II. Title

The name of the aforesaid Board shall be "Lower Makefield Township Park and Recreation Board".

SECTION III. Members of Board and Terms of Office:

The members of the aforesaid Park and Recreation Board shall be five and serve for a term of five years. The following members shall begin their term, as indicated, November 1, 1967:

- Harold Bush shall serve for a term of five years;
- Richard Guzikowski shall serve for a term of four years;
- Richard Polchinski shall serve for a term of three years;
- Marion Dahlman shall serve for a term of two years;
- Alfred Raws shall serve for a term of one year.

SECTION IV. Vacancies

All persons appointed shall serve their full terms unless voluntarily resigned or removed by the supervisors for dereliction or neglect of duty. Vacancies in such board accruing otherwise than by expiration of term shall be for the unexpired term, and shall be filled in the same manner as original appointments. All members shall serve without pay.

SECTION V. ORGANIZATION OF BOARD

The members of the Park and Recreation Board established by this Ordinance, shall elect their own chairman and secretary, and select all other necessary officers, to serve for a period of one year. Said Board shall have to adopt rules and regulations for the conduct of all business before them.

SECTION VI. POWERS, DUTIES, COOPERATION

The Park and Recreation Board shall assist the Township Supervisors in planning, laying out and maintaining parks, recreation facilities and programs recommending to the Board of Supervisors such plans and provisions as it deems necessary, and indicating the cost of such to the Supervisors so that they may be prepared to allow for such program in the budget of each succeeding year for equipment, maintenance and personnel for such program.

The Park and Recreation Board shall have the full assistance, advice and cooperation of the Township Manager and staff and of the other Boards, Commissions and Agencies of the Township. The Board shall work whenever possible with the School Authorities.

SECTION VII. REPORTS

The Board is hereby directed to periodically report to and consult with the Board of Supervisors in order to keep the latter informed of its activities and it should also provide an annual written report.

SECTION VIII. REPEALER

All ordinances or parts of ordinances inconsistent herewith are hereby repealed.

SECTION IX: VALIDITY

Should any section or provision of this amended ordinance be declared invalid by any court of competent jurisdiction, such decision shall not affect the validity of the amended ordinance as a whole, or any other part thereof.
