AN ORDINANCE OF THE TOWNSHIP OF LOWER MAKEFIELD, BUCKS COUNTY, PENNSYLVANIA, VACATING AN ABANDONED TOWNSHIP ROADWAY FORMERLY KNOWN AS OLD OXFORD VALLEY ROAD AND TO ESTABLISH AN EFFECTIVE DATE THEREBY

WHEREAS, the Township of Lower Makefield is a township of the second class, organized and operating in accordance with the laws of the Commonwealth of Pennsylvania; and

WHEREAS, pursuant to the Second Class Township Code of the Commonwealth of Pennsylvania, the Board of Supervisors of Lower Makefield Township (hereinafter referred to as the "Township") has the authority, *inter alia*, to enact, open, widen, lay out and vacate all roads located within the Township in accordance 53 Pa. C.S. Section 67304, as amended; and

WHEREAS, the Township is the owner of a certain roadway known as Old Oxford Valley Road, located off Big Oak Road near the former Matrix property within the Township, as more fully described in Exhibit "A" and as depicted in the aerial photograph attached hereto as Exhibit "B"; and

WHEREAS, the roadway known as Old Oxford Valley Road is no longer accessible and useful to the Township, its residents and the public as Oxford Valley Road has been reconfigured by the Commonwealth of Pennsylvania; and

WHEREAS, the Township no longer wishes to own Old Oxford Valley Road and seeks to vacate the roadway to be distributed to the adjacent property owners in accordance with applicable law.

NOW, THEREFORE, BE IT AND IT IS HEREBY ORDAINED AND RESOLVED that the Township of Lower Makefield does and hereby vacates the roadway known as Old

Oxford Valley Road, as more fully described in Exhibit "A", and located as depicted in Exhibit "B" as attached hereto.

AND BE IT FURTHER ORDAINED AND RESOLVED that all appropriate officers of the Township are hereby authorized to take any and all other necessary steps in order to effectuate the terms of this Ordinance.

AND BE IT FURTHER ORDAINED AND RESOLVED that all other ordinances, portions of ordinances, or any section of the Code inconsistent with this Ordinance, are hereby repealed.

SEVERABILITY

The provisions of this Ordinance are severable. If any section, clause, sentence, part or provision thereof shall be held illegal, invalid or unconstitutional by a court of competent jurisdiction, such decision of the court shall not affect or impair any of the remaining sections, clauses, sentences, parts or provisions of this Ordinance. It is hereby declared to be the intent of the Township Board of Supervisors that this Ordinance would have been adopted if such illegal, invalid or unconstitutional section, clause, sentence or part of a provision had not been included herein.

DESCRIPTION OF A PARTIAL VACATION AND BLANKET UTILITY AND ACCESS EASEMENT FOR OLD OXFORD VALLEY ROAD IN FAVOR OF LOWER MAKEFIELD TOWNSHIP BUCKS COUNTY, PENNSYLVANIA

All the certain tract or parcel of land and premises known as Old Oxford Valley Road, situate, lying and being in Lower Makefield Township, County of Bucks, Commonwealth of Pennsylvania, and being more particularly described as follows:

BEGINNING at the northwest intersection of the legal right-of-way lines of Big Oak Road (SR 2024) (97.5 foot R/W) and Old Oxford Valley Road (76.5 foot R/W), being the southeast corner of PARID: 20-032-026-001 (N/L Aurliz LLC), thence extending from said point of BEGINNING:

- 1. Along the western legal right-of-way line of Big Oak Road, North 03 degrees 18 minutes 46 seconds West a distance of 250.00 feet to a point; thence
- 2. Leaving the western legal right-of-way line and passing through the bed of Old Oxford Valley Road to a point on the eastern legal right-of-way line of Old Oxford Valley Road, a point on the western line of PARID: 20-032-026-001 (N/L Otto F.
