ORDINANCE NO.

AN ORDINANCE OF THE TOWNSHIP OF LOWER MAKEFIELD, BUCKS COUNTY, PENNSYLVANIA, AMENDING CHAPTER 178, "SUBDIVISION AND LAND DEVELOPMENT," TO MODIFY THE PROVISIONS OF TREE REPLACEMENT AND PROTECTION RELATED TO THE COSTS PER REPLACEMENT TREE, AND TO MODIFY THE PROCESS FOR DETERMINATION OF FUTURE COSTS FOR REPLACEMENT TREES, TO REPEAL INCONSISTENT PROVISIONS, AND TO ESTABLISH SEVERABILITY AND EFFECTIVE DATE

WHEREAS, the Township of Lower Makefield, Bucks County, is a township of the second class, organized and existing in accordance with the laws of the Commonwealth of Pennsylvania; and

WHEREAS, the Township, in the exercise of its corporate powers, has the authority to enact, amend, repeal and establish ordinances and regulations governing subdivision and land development projects and plans within the Township's territorial boundaries; and

WHEREAS, the Township, after due consideration and review, finds it would be in the best interest of the Township to amend its regulations for subdivision and land development provisions of tree replacement and protection related to the costs per replacement tree, and to modify the process for determination of future costs for replacement trees within the Township.

NOW, THEREFORE, be it ORDAINED and ENACTED as follows:

§ 178-85.H.(4)(d)[2] Tree Protection Standards/Tree Replacement which states:

The contribution by the developer to the tree bank will be \$347 per replacement tree. Three years after adoption of this subsection, and every three years thereafter, the contribution per replacement tree will be adjusted to reflect the compounded annual changes in the All Urban Consumers Price Index (CPI-U) as reported by the U.S. Bureau of Labor Statistics. Any increase in the amount of the tree bank contribution shall be memorialized by the approval of a resolution by the Board of Supervisors.

SHALL BE **DELETED** IN ITS ENTIRETY AND **REPLACED** WITH:

The contribution by the developer to the tree bank will be \$374.00 per replacement tree. Annually, the contribution per replacement tree will be adjusted to reflect the annual change in the Consumer Price Index for All Urban Consumers (CPI-U) for the 12-month period ending each October as reported by the U.S. Bureau of Labor Statistics. Any increase in the amount of the tree bank contribution shall be memorialized by the approval of a resolution by the Board of Supervisors.

General Provisions

A. All other provisions of § 178-85 not specifically modified herein shall remain in full force and effect.

B. The provisions of this Ordinance are severable. If any section, clause, sentence part or provision thereof shall be held illegal, invalid, or unconstitutional by a court of competent jurisdiction, such decision of the court shall not affect or impair any of the remaining sections, clauses, sentences, parts or provisions of this Ordinance. It is hereby declared to be the intent of the Township of Lower Makefield that this Ordinance would have been adopted if such illegal, invalid or unconstitutional section, clause, sentence or part of a provision had not been included herein.

C. This Ordinance shall be effective five (5) days after enactment by the Board of Supervisors of Lower Makefield Township, Bucks County, Pennsylvania.
