Tree Bank Update

Projects Subject to Contributing to the Tree Bank Ordinance

The contribution to the tree bank is due at the time of development agreement execution with the Township. This normally occurs just before construction begins.

The replacement tree fee was increased from \$347 to \$374 in ordinance 178-85.H(4)(d)[2] at the July 17, 2024 BOS meeting.

Projects Owing Tree Bank

<u>1181 Oxford Valley LLC</u> – Preconstruction meeting Sept. 19, 2023. Tree removal started. Approx. 7 tree greater than 10". From Nov. 3, 2021 BOS meeting: "He stated they will document which trees are dead; and if replacement trees are required under the Ordinance, they will put in replacement trees on the property."

<u>1566 LCC – Preliminary Plan approved by BOS on July 20, 2022. Final Plan approved by BOS Oct. 4, 2023. 921 replacement trees required. 167 will be planted on-site, maybe more. 754 tree payment (\$261,638) to the Tree Bank currently required in escrow per Aug. 4, 2023 BOS meeting. Additional trees planted on-site will reduce escrow. [J.M. 12/6/23 email, payment estimated to be \$150,000 for approx. 432 trees]. Not under construction.</u>

<u>1273 Lindenhurst Subdivision</u> - Preliminary/Final Plan approved by BOS April 19, 2023. 69 replacement trees; 39 will be planted on-site, 30 trees into Tree Bank. [per J.M. 12/6/23 email, developer owes \$10,328, ~27 trees]. Not under construction.

<u>Dogwood Drive</u> – per Oct. 18, 2022 court settlement, \$25,000 to Tree Bank when development agreement signed. Not under construction.

<u>Jorge Gomez 1442 Oxford Valley Rd.</u> – per EAC 2/11/2021 comment letter, 632 ft of woodlands to be removed. Pre/final plan approved April 21, 2021. Not under construction. Tree Bank?

<u>The Point</u> – 0.76 acres, 13 housing units in five separate buildings. Preliminary/Final Plan approved by BOS Dec. 6th, 2023. 92 replacement trees required plus 4 street trees. \$33,312 is owed the tree bank.

Projects Contributing to Tree Bank in 2024

<u>1101 Big Oak Subdivision</u> – Preliminary/Final Plan approved by BOS May 31, 2023. Approx. 215 replacement trees required. \$78,166 paid by developer June 14, 2024

- 4. 2023 fall tree planting at Caiola and Fred Allen Fields. 162 trees, \$62,503
- 5. Regency at Yardley Tree Planting. \$3,376
